Tom Lawlor, West Central Development Corporation, and Bob Broomfield, Harlan Community School Superintendent, appeared before the Board to discuss a joint project to construct a building to house the pre-school programs at an approximate cost of \$1,119,604. The proposed building would be constructed on the New Park Elementary School site, just north of the tennis courts at 10<sup>th</sup> & Cyclone in Harlan. It was moved by Petersen, seconded by Ferry, to approve the pre-application for a Community Development Block Grant for \$600,000 to be used for the project, with the County being the applicant. Jason Dinesen introduced himself to the Board as the full-time News Director at KNOD Radio Station in Harlan.

Randy Arnold, Arnold Insurance Agency, appeared before the Board to update the Board on the Principal Health Insurance Renewal. Also discussed was the Flex Medical Spending Cap. WHEREAS, said operating transfers are in accordance with Sections 331.427 and 331.428, Code of Iowa,

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Shelby County, Iowa, as follows:

The Auditor is hereby authorized to transfer funds from the Rural Basic Fund to the Rural Supplemental Fund for rural county services for Fiscal Year 2002 an amount not to exceed \$50,000, or a proportionate share of the taxes collected.

WHEREAS, in accordance with Section 331.434(6) of the Code of Iowa which requires the Board of Supervisors of Shelby County, Iowa, to appropriate funds to operate all offices and departments of said county for Fiscal Year 2002.

THEREFORE BE IT RESOLVED, that the Board of Supervisors do hereby authorize the appropriations for Fiscal Year 2002 as follows:

SECTION 1: The amounts itemized by fund and by department or office on the following Schedule A are hereby appropriated from the resources of each fund so itemized.

SECTION 2: Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2001.

SECTION 3: In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amount appropriated pursuant to this resolution.

SECTION 4: If at any time during the budget year the Auditor shall ascertain that the available resources of a fund for that year will be less than said funds total appropriations she shall immediately so inform the Board and recommend appropriate corrective action.

SECTION 5: The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate on a report the status of such accounts to the applicable department and offices monthly during the budget year.

SECTION 6: All appropriations authorized pursuant to this resolution lapse at the close of business June 30, 2002.
