SHELBY COUNTY ORDINANCE NO. 2001-3 AN ORDINANCE TO RE-PRECINCT SHELBY COUNTY AND ADJUST VOTING PRECINCT BOUNDARIES

(REPLACES ORDINANCE NO. 1991-5)

BE IT ENACTED BY THE SHELBY COUNTY BOARD OF SUPERVISORS:

SECTION 1. <u>Purpose</u>. The purpose of this ordinance is to re-precinct Shelby County in this year following the Federal Decennial Census as required by Section 49.7, Code of Iowa.

SECTION 2. <u>Division into Precincts</u>. The County of Shelby is divided into sixteen (16) precincts. The number of precincts, precinct name, precinct population, and legal descriptions are described in the attached exhibit marked as Exhibit A and, by this reference, made a part hereof.

SECTION 3. When Effective. This ordinance shall be in effect after its final passage, approval, and publication as provided by law.
