Included in this Act is the federal requirement that by 2006, "states also will be required to have voting machines that allow voters to confirm the way they marked their ballot – and, if necessary, change their votes – before they are finally cast." Carter estimates the cost of this new equipment for Shelby County to be approximately \$100-150,000.
