A discussion was held on the lease for the County Care Facility, currently being leased by Country Care Corporation. Discussion was held on the length of the lease and who would be responsible for major repairs. After much discussion, it was moved by Ferry, seconded by Schmitz, to authorize the County Attorney to draw up a five-year lease, with an addendum concerning major repair costs. The County Engineer updated the Board on ongoing Secondary Road projects.

A highway, the centerline of which is described as follows: A section of road #75 as established December 9, 1871 the centerline of which is described as follows:

Commencing at a point 1309.7 feet east along the section line east of the NE Corner Section 32-81-40 (Grove Township, Shelby County, Iowa) and running easterly along the section line and terminating at a point 169.9 feet west of the NE Corner 33-81-40.

ITEM NO. 2 GROVE

A highway, the centerline of which is described as follows: A section of road #752 as established November 9, 1903 the centerline of which is described as follows: Commencing at a point 1383.2 feet east of the NE Corner 33-81-40 (Grove Township, Shelby County, Iowa) thence running south distance of 2136.12 to the point of termination.

ITEM NO. 3 GROVE

A highway, the centerline of which is described as follows: A section of road #824 as established March 4, 1925 the centerline of which is described as follows: Commencing at a point 1873.77 feet west and 185.94 north of the E1/4 Corner 33-81-40(Grove Township, Shelby County, Iowa) thence running north easterly a distance of 627.5 feet to the point of termination.

ITEM NO. 4 DOUGLAS

A highway, the centerline of which is described as follows: A section of road #179 as established July 19, 1875 the centerline of which is described as follows: Commencing at a point on the section line, 1322.5 feet south of the NE1/4 Corner 23-80-38 (Douglas Township, Shelby County, Iowa) thence running south along the section line terminating at the SE Corner 23-80-38.

The Chair opened said hearing at 9:45 a.m. and read opening remarks.

Items 1, 2 and 3 were addressed first. The County Engineer gave a presentation on the proposed vacation and abandonment. The Clerk reported having received written no comments. Regarding Item 4 above, the Board reviewed the comments made and heard a report by the County Engineer that all necessary work has been completed to remove the old roadway and to complete all survey and legal work involved in the land transactions above described. It was moved by Schmitz, second by Ferry to vacate the described road as follows:

ROAD VACATION RESOLUTION NO. 2003-27

The Board took final action on the hearing and Engineer's report of October 7, 2003, related to the vacating and abandoning of right of way for sections of the Shelby County Secondary Road system as described below.

The Board heard a report from the County Engineer that all crossings, fences and banks were removed and section lines established.

IT IS THEREFORE ordered that the following sections of the Shelby County Secondary Road system be vacated, the crossings abandoned and all right of way abandoned.
