RESOLUTION AUTHORIZING AND DIRECTING THE CHAIR TO MAKE AN APPLICATION TO THE FY2004 IOWA HOUSING FUND PROGRAM FOR ASSISTANCE TO COMPLETE THE HOUSING REHABILITATION PROGRAM

WHEREAS; Shelby County has found a need for housing rehabilitation in the county; and

WHEREAS; Shelby County proposes to create a housing rehabilitation program. This program expects to rehabilitate twelve (12) single-family, owner-occupied, low-moderate income housing units.

NOW THEREFORE, BE IT RESOLVED BY THE COUNTY SUPERVISORS OF THE COUNTY OF SHELBY, as follows:

SECTION 1: Shelby County Supervisors authorize and direct the Chair to make an application to the FY2004 Iowa Housing Fund for \$300,000. The County and the City of Harlan will contribute \$30,000 for local match to complete the Housing rehabilitation Program as follows:

Rehabilitation (12 units):

Program Funds \$292,500 Local Contribution \$30,000 Grant Administration \$7,500

SECTION 2: These programs will be available throughout Shelby County.

It was moved by Schmitz, seconded by Petersen, to appoint Judson Frisk, Harrison County Attorney, as Assistant Shelby County Attorney at no cost to Shelby County. AYES: Petersen, Schmitz, Ferry NAYES: None

A discussion was held on the Law Enforcement Contracts with the cities in Shelby County. The Board will discuss this issue again at the next meeting.

It was moved by Schmitz, seconded by Petersen, to transfer \$250,000 from General Basic to General Supplemental and \$2525.40 from the Insurance Reimbursement Fund to Secondary Road. AYES: Petersen, Schmitz, Ferry NAYES: None

A discussion was held on the funding of the Emergency Services Association. It was moved by Ferry, seconded by Petersen, to authorize the Chairman to sign a letter to the ES Association, notifying them that Shelby County will deny any funding requests for FY2005, with the note that when the Townships are funding the Fire and Rescue Services at their maximum levy of \$.60750 and the Townships are still not able to fund essential services, another proposal can be made at that time. This being the time and date advertised for a public hearing on the proposed road vacation on the following site: A portion of road along the north line, Section 2, T-81N, R-37W, Jefferson Township, 1700 Block Apple Rd., Shelby County (also described as south line, Section 35, T-82N, R-37W, Iowa Township, east of 380th Street on 'Y' Street, Crawford County) as follows: A section of a highway, part of Road #668 as established December 12, 1891, the centerline of which is described as follows: Commencing at the NW corner Section 2, T-81N, R-37W, and terminating at a point easterly along the north line of said Section 2, a distance of two thousand nine hundred twenty (2,920) feet being a point on the east bank of the West Nishnabotna River. The Chair opened said hearing at 9:30 a.m. and read opening remarks. The County Engineer gave a presentation on the proposed vacation and abandonment. The Auditor reported having received no written or oral comments. The floor was opened to receive comments. No one appeared speaking in favor or opposed to the action. There being no other comments, it was moved by Ferry, seconded by Schmitz, to vacate and abandon the above described right of way, abandon all stream crossings therein, and to revert the land to adjacent landowners as per Iowa Code and to close the public hearing.
