The Auditor informed the Board that most recent estimates were that Shelby County would receive \$98,000 in HAVA funding for the future purchase of our new voting equipment. The estimated cost for Shelby County is approximately \$150,000 for 17 precincts. A discussion was held on the possibility of eliminating some precincts to save equipment costs. The new equipment is required to be in place by any federal election after January 1, 2006.

A discussion was held on the precincts for the upcoming Local Option Sales Tax Election on March 8, 2005. The Board decided to set up five precincts throughout the County. The Board also discussed the informational ad for the newspapers.

The Auditor informed the Board that our current software provider will be phasing in new software for our real estate and taxation records over the next 2-3 years. The cost for Shelby County will be approximately \$72,000 for software and training. \$50,000 has already been set aside for this purchase plus the Assessor will be funding approximately one fourth of the equipment cost, or \$15,000 and the Recorder will be using \$10,000 from the Recorders Management Fund to help pay for the Recorder's portion of the software.
