It was moved by Christensen, seconded by Ferry, to approve the Claims of March 31, 2008, as listed in the Claims Register. AYES: Schmitz, Ferry, Christensen NAYES: None

Josh Hansen, Heartland Technology, appeared before the Board to explain the necessity for the additional SPAM coverage currently implemented by the IT Department. He presented a report showing that 210,151 emails were sent to Shelby County users during a recent 30-day period and 181,484 were SPAM and captured by the software.

A discussion was held on the whether or not Shelby County should become a member of NACO, National Association of Counties. The dues are \$400 annually. No action was taken, but the County's memberships to all organizations will be reviewed at budget time.

RESOLUTION NO. 2008-8 WEED DESTRUCTION PROGRAM

BE IT RESOLVED, that pursuant to the provisions of Chapter 317, Code of Iowa, it is ordered:

That each owner and each person in possession or control of any lands in Shelby County, shall cut, burn or otherwise destroy all noxious weeds thereon, as defined in the chapter, at such time in each year and in such manner as shall prevent such weeds from blooming or coming to maturity, and shall keep said lands free from such growth as shall render the streets or highways adjoining said lands unsafe for public travel. Noxious weeds shall be cut or otherwise destroyed as published in the official newspapers of Shelby County.

That, if owners or persons in possession or control of any lands in Shelby County fail to comply with the foregoing orders, the weed commissioner shall cause this to be done and the

expenses of said work including cost of serving notice and other costs, if any, to be assessed against real estate.

THEREUPON, the Board instructed the County Auditor to place said notice in the official newspapers of Shelby County.

The above and foregoing resolution was adopted by the Board of Supervisors of Shelby County, Iowa, on April 1, 2008, the vote thereon being as follows:

Ahart also took the opportunity to remind the public that taking rock off the roads and putting it on private property is considered theft.

It was moved by Christensen, seconded by Ferry, to approve the purchase of a single axle cab and chassis truck from Cornhusker International, Omaha, Nebraska, at their quoted price of \$60,497.34, plus the dump body, snow wing and snow plow for same from Steffen, Sioux City, for their quote price of \$31,703.00. It was moved by Ferry, seconded by Christensen, to approve the plans and specifications for Grading Project LS-08-25G (Dairy Road) in Douglas Township and to set 9:30 a.m. on April 22, 2008, as the deadline for the Auditor's Office to accept bids on said project.
