An alert bank employee had noticed that even though the type font was identical, the ink was slightly darker on the name and address. A stop payment was successfully issued on the check immediately. Tom Ouren from The Agency, the County's insurance carrier, is researching the County's coverage should this happen again, but is not caught at the bank.

Countryside Enterprises (Golf Course) – Smoking will not be allowed in the clubhouse or the areas to the east sidewalk, to the south sidewalk north of number one tee box, and west to cart shed number 3, and north to the fence. Smoking will be allowed in all other areas.

Courthouse, Annex, Law Enforcement/911 Center, Secondary Road, and Landfill Grounds – No designated smoking areas
