It was moved by Burmeister, seconded by Hull, to approve the Claims of April 30, 2009, and place the listing on file in the Auditor's Office. AYES: Schmitz, Hull, Burmeister NAYES: None

Amanda Brewer, WESCO, presented their annual update. It was moved by Burmeister, seconded by Hull, to approve the Provider and Participation Agreement with WESCO. AYES: Schmitz, Hull, Burmeister NAYES: None

Lonnie Maguire, Community Services Director, presented the Shelby County Case Management Projected Cost Report for FY2010, with the new rate set estimated at \$71.78 per 15 minute increment. This will bring in an additional \$25,000 approximately for Case Management expenses. It was moved by Burmeister, seconded by Hull, to approve the Shelby County Case Management Projected Cost Report for FY2010 for submission to IME at the State level. It was moved by Hull, seconded by Burmeister, to authorize the Chairman to sign the Community Mental Health Center Affiliation and the Community Mental Health Center Waiver Request for FY2010 and approve for submission to the Iowa Department of Human Services. Maguire also stated that State funding had been cut \$18 million state-wide and that the Property Tax Relief funding could possibly be cut, because we may be getting some Federal Stimulus money. This would be applied as a credit to any State Institution bills for our county. Maguire is still estimating year end shortages of 1% for FY2010, 12% for FY2011, and 30% for FY2012, if the State continues to cut the funding sources. Shelby County's only option will be to cut MH/MR/DD services.

Mark Hervey, Shelby County Sheriff, appeared before the Board to discuss the current charges for Jail Room and Board. It was moved by Schmitz, seconded by Hull, to approve an increase in the Jail Room and Board charge from \$20.00/day to \$25.00/day with the weekend rate to remain at \$30.00/day as June 1, 2009; to use the revenue generated from the Jail Room and Board charge to purchase Inmate Excess Medical Insurance from Correctional Risk Services at their current annual rate of \$5,760; and to authorize the Sheriff to sign the necessary documents. AYES: Schmitz, Hull NAYES: Burmeister

It was moved by Burmeister, seconded by Hull, to approve Hervey's request to amend the Sheriff's Department Budget for FY2009 by \$50,000. AYES: Schmitz, Hull, Burmeister NAYES: None

Representatives of Country Care Center presented the annual update.

Dave Radke, Williams and Company, presented the FY2008 Shelby County Audit. The contract for the FY2009 and FY2010 audit was discussed, but no action was taken.
