WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

#### SHELBY COUNTY DISASTER DECLARATION

"Shelby County has suffered from a winter storm that began December 22 and continuing. This caused severe damage to public and private property, disruption of utility service and endangerment of the health and safety of the citizens of Shelby County within the disaster area.

Therefore the Shelby County Board of Supervisors has declared a state of emergency authorized under Iowa State Statute and will execute the expenditure of emergency funds from all available sources, invoking of mutual aid agreements, and applying to the State of Iowa for assistance, and to request further assistance from FEMA.

Specific resources requested are in the form of snow removal equipment, two large snow blowers and operators. The basis for this request is the fact that our rural citizens are finding themselves in dangerous situations. While county road crews are attempting to clear the rural roads, the wind is blowing them full as fast as they are plowed. At this point concerns include access for emergency services, food, and heating and fuel supplies, access to medical supplies and medication. In Addition, the ability to care for livestock is being impeded.

Our request is for two large snow blowers and any other snow removal equipment available to help with clearing secondary roads. This will allow for more efficient removal of the deep drifts in the cuts on our rural roads."
