Rob Lawson and Don Bladt, NRCS, presented their annual report of the repairs done in 2009 on the Flood & Erosion Control Structures and work scheduled for 2010.

Gene Cavenaugh, Veterans Affairs Director, appeared before the Board to explain the use of the \$10,000 State funding received by the Veterans Affairs Commission.

Ron Chamberlain and other interested parties appeared before the Board to request \$1,250 for the roof replacement on the Panama Historic One Room School House Museum. The request was denied.

Carolyn Blum, Treasurer, appeared before the Board to review the Treasurer's Depository Resolution and Investment Policy. It was moved by Burmeister, seconded by Schmitz, to approve the Shelby County Investment Policy and Depository Resolution as presented on February 20, 2007 with no changes. It was moved by Schmitz, seconded by Burmeister, to grant Audubon County access to Shelby County's financial software in case of an emergency/disaster so they would be able to continue business as usual until their systems are operational. AYES: Hull, Schmitz, Burmeister NAYES: None

David Yamada, Shelby County DevelopSource, updated the Board on the economic development projects for Shelby County.

Dan Ahart, the County Engineer, updated the Board on activities of the county road crews and the status of current maintenance and construction projects.

Ahart updated the Board on the blizzard of December 24/25, 2009 and the ongoing cleanup. Governor Chet Culver's Disaster Declaration for Shelby County had allowed the Iowa DOT to loan Shelby County a snow blower with fuel plus an operator. To date, the State's snow blower had been in operation for Shelby County a total of 216 hours. Shelby County has now purchased its own snow blower to be ready for future storms.

Marsha Carter, Auditor and Budget Director, presented eight different options to the Board for the FY2011 Proposed Budget. After much discussion, it was moved by Schmitz, seconded by Burmeister, to approve Option #7 of the FY2011 Shelby County Budget, which lowers the County's total tax asking from the FY2010 level by \$100,000.
