Over the last few years, Hervey has been replacing the patrol cars with 4WD/4 door pickups, which he can purchase through the State contract at a cost of \$19-23,000. This is less than he was paying for the patrol cars. He is now researching the cost of a 4WD SUV. Preliminary prices are comparable to the pickups. He will do more research and bring that information to the Board at a future meeting.

Carter reported that ISAC has notified the Board that the County has met the requirements of the Wellness Program to qualify for the additional 5% discount on our health insurance premium for FY2013, which is a savings of approximately \$45,000. The Board stated their appreciation of the employees' participation to make this a successful program.

Dan Ahart, County Engineer, was not available to update the Board on activities of the county road crews and the status of current maintenance and construction projects.
