The Board of Supervisors of Shelby County, Iowa, met pursuant to law and rules of said board in regular session at 9:00 a.m. in the Supervisors Chambers of the Shelby County Courthouse with the following members present: Charles Parkhurst, Chairman; Roger Schmitz, Vice Chairman; Steve Kenkel; and Marsha J. Carter, Clerk.

The Chair asked that any Conflict of Interest be stated concerning any item on the agenda. No conflicts were stated.

It was moved by Schmitz, seconded by Kenkel, to approve the agenda with the following additions: (1) Corrective Transfer from Secondary Road to General Supplemental. (2) Approve Tax Credits for 2014 Property Taxes. AYES: Parkhurst, Schmitz, Kenkel NAYES: None

Representatives from the Elk Horn area appeared before the Board to discuss a bridge closing near the Elk Horn Park. A representative from the Shelby County Conservation Board was also present and expressed the concerns from some of the people who pull campers to the park. County Engineer Dan Ahart stated that the bridge has not been officially closed, but has been barricaded for safety reasons due to the poor condition of the bridge. He presented the inspection reports, past maintenance records and possible costs for future maintenance on this bridge to make it a legal bridge. All agreed that more signage was needed. The Supervisors agreed to discuss the repair/replacement of this bridge when the Secondary Roads Five-Year Plan is reviewed in December. Supervisor Kenkel did want the group to understand that currently the Five-Year Plan only addresses 49% of Shelby County bridges that are in need of repair.
