Southwest Iowa Mental Health conditions and status and new information was reported by Suzanne Watson. New efficiencies are starting to be utilized in the system and the cost per capita is less than half of what they were a few years ago. She noted that their funding may need to be increased in the coming years as using existing capital is being used up.

Laci Litton, WellMark, appeared before the Board to give the annual update on the ISAC Health Insurance Plan and the County employee’s utilization. Discussion was also held on the Health Savings Account Plan as a second option for the employees.

Todd Valline advised the board about current Chamber of Commerce activities. The county/city/lighting committees are working to coordinate to achieve a single entity to look over installation, takedown and storage of lighting in the future. A special thanks was given to HMU for removing some of the lights a week ago and for storing the lights.

Dan Ahart, County Engineer, was available to update the Board on activities of the county road crews and the status of current maintenance and construction projects. The weather has not aided in any improvement in road conditions and the weather must cooperate to get them to improve for maintenance.

Kyle Lindburg updated the board concerning the camera install at the jail. All seems to be working as it should since install was completed, monies to be used from the Sherriff/Jail revenue fund. The billing from the contractor has been gone over by Lindburg and a copy of correct billing has been given to the Auditor.

Mark Maxwell presented a brief report concerning the areas of his over sight, consisting today of the budget and an approval of a special meeting date of February 28, 2017 at 9:00 AM, also this will be used as a replacement of the regular meeting scheduled for March 7, 2017consideration of options presented as the Auditor is able. The tentative final budget hearing date of March 14, 2017 planned. Maxwell made a special thank you to Marsha Carter for answering a few questions for him, and also Auditors in Audubon and Harrison County for their assistance. The township budget hearings are this evening at 6:00 in the courtroom. IT questions were answered from the board by Maxwell including a directive by Maxwell of no expenditures over \$100.00 with clearing through Maxwell first for all except essential services, until further notice, the IT expenditures come under control.
