The Board of Supervisors of Shelby County, Iowa, met pursuant to law and rules of said board in special session at 9:00 a.m. in the Supervisors Chambers of the Shelby County Courthouse with the following members present: Darin Haake, Chairperson, Steve Kenkel Vice Chairperson and Charles Parkhurst, Supervisor also Mark Maxwell Shelby County Commissioner of Elections.

The Chairperson asked that any Conflict of Interest be stated concerning any item on the agenda. None were stated.

It was moved by Kenkel, seconded by Parkhurst, to approve the agenda. AYES: Parkhurst, Haake and Kenkel NAYES: None

It was moved by Kenkel and seconded by Parkhurst to approve the minutes of November 2nd, 2021 board meeting. Motion passed.

Lots were drawn to determine the result of the Earling Council person At Large race that was open, and no one ran for the position. Two persons tied, each with two write in votes. Chairperson Haake drew lots and Joey Muenchrath had his name drawn for the position.

**RESOLUTION 2021-32 – CERTIFICATION (CANVASS) OF SHELBY COUNTY
ELECTION RESULTS,
COMBINED CITY-SCHOOL ELECTION**

WHEREAS, the CITY-SCHOOL ELECTION was held as prescribed by law on November 2, 2021, and WHEREAS, the Board of Supervisors and ex-officio Board of Canvassers have canvassed the vote of said elections in accordance with §50.24 of the *Code of Iowa*, now therefore BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors and ex-officio Board of Canvassers of Shelby County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the CITY-SCHOOL ELECTION, held November 2, 2021, and that no obvious clerical errors were identified during the canvass. One Thousand five hundred fifty two (**1,552**) people voted at the polls on election day. Two hundred twenty seven (**227**) absentee ballots were accepted for counting. One (1) provisional ballot was accepted for counting. A total of one thousand seven hundred eighty (**1,780**) people voted.

All races are for a term of four (4) years unless otherwise noted.
