WHEREAS, Shelby County Iowa has no existing ordinance governing the siting, construction, and operation of commercial wind energy systems in unincorporated areas of Shelby County, Iowa, AND WHEREAS, the County has an interest in protecting the County's infrastructure, natural resources and property rights through adequate provisions governing the siting, construction, and operation of commercial wind energy systems, AND WHEREAS, the Board of Supervisors will require substantial time to gather information and coordinate with multiple agencies for the purpose of reviewing, updating or creating ordinances, policies and procedures relative to commercial wind energy systems, AND NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Shelby County Iowa, that Shelby County now imposes a moratorium, effective immediately on April 18th, 2023 and for a period of one-hundred eighty days, on the siting, construction, and operation of commercial wind energy systems, for the purpose of drafting and adopting an ordinance regulating commercial wind energy systems.

WHEREAS, Shelby County Iowa has no existing ordinance governing the siting, construction, and operation of commercial solar energy systems in unincorporated areas of Shelby County, Iowa, AND WHEREAS, the County has an interest in protecting the County's infrastructure, natural resources and property rights through adequate provisions governing the siting, construction, and operation of commercial solar energy systems, AND WHEREAS, the Board of Supervisors will require substantial time to gather information and coordinate with multiple agencies for the purpose of reviewing, updating or creating ordinances, policies and procedures relative to commercial solar energy systems, AND NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of Shelby County Iowa, that Shelby County now imposes a moratorium, effective immediately and for a period of one-hundred eighty days, on the siting, construction, and operation of commercial solar energy systems, for the purpose of drafting and adopting an ordinance regulating commercial solar energy systems.
