The residing Chair, Steve Kenkel, asked that any conflict of interest be stated concerning any item on the agenda. None were stated.

It was moved by Schaben, seconded by Parkhurst, to approve the agenda. Motion carried unanimously.

It was moved by Parkhurst, seconded by Schaben to approve the minutes of December 19th, 20th and 21st, 2023. Motion carried unanimously.

It was moved by Schaben, seconded by Parkhurst, to approve the claims of December 29th, 2024, as listed in the claims register. Motion carried unanimously

Parkhurst made a motion to recess the current meeting to hold a public hearing for an amendment to the fiscal year 2024 budget. Schaben seconded the motion, the motion passed.

Having no comments from the public previously or at this meeting, Parkhurst made a motion to close the hearing, Schaben seconded the motion. The motion passed.

Explanation of Changes: EMS Startup, grant expenditures ARPA expenditures, plan for air conditioner replacement at Courthouse, cost shifting to general supplemental, unplanned employee health insurance coverage. Selling of flood mitigation credits and expenditure of flood mitigation credits.

A vote was tallied with Schaben, Parkhurst and Kenkel all voting in favor of the resolution. No Nays were cast, the motion passed.

It was moved by Schaben, seconded by Parkhurst, that all claims filed in the Auditor's office by the Wednesday before the third Tuesday of each month shall be presented to the Board of Supervisors for approval for payment at that meeting. All claims for mileage and expenses must be submitted within sixty days of the date incurred. Payroll timesheets will be submitted by 8 AM the Monday before payday for hourly employees. Late time sheets will be noted and counted and department heads will be responsible for their employees turning in time sheets to the Auditors office by 8:AM Monday before payday. Motion carried unanimously. It was suggested by the Auditor that timesheets be delayed one week to allow more than 4 days to approve time sheets.

The Supervisors then considered the 1% increase in wages for Calendar year 2024 for those employees that qualified. Parkhurst made a motion to award the increase for the calendar year 2024. Schaben seconded the motion, the motion passed.

The new GIS agreements were then considered with the Harlan Municipal Utilities and the City of Harlan; the new contracts yearly costs were updated for the first time since at least 2011. Any increase in staff augmentation costs in the future will be split evenly between HMU, The City of Harlan and Shelby County. Schaben made a motion to allow the Chairperson to sign the contract. Parkhurst seconded the motion, the motion passed.

Bonds for the required Elected officials were then considered, Iowa code requires these bonds to be in force. Parkhurst made a motion to acquire and approve the bonds and ask a District Court Judge to approve the Supervisors bonds as also required. Schaben seconded the motion, the motion passed.

Todd Valline Executive Director of the Shelby County Chamber of Commerce was present and thanked all volunteers and Chamber members for their efforts over the holiday season in Shelby County.

It was moved by Schaben, seconded by Parkhurst, to approve the following resolution: **RESOLUTION NO. 2024-1 ECONOMIC DEVELOPMENT PUBLIC PURPOSE STATEMENT**

BE IT RESOLVED by the Shelby County Board of Supervisors that the funding of Shelby County Develop Source and Shelby County Area Wide Chamber and any other economic development project deemed appropriate by the Board is an economic development project as defined in Iowa Code Section 15A.1 and that this expenditure would further a public purpose, that public purpose to be an expansion or retention of jobs in Shelby County. Any business receiving economic development funding from Shelby County will be required to abide by the policies set by Shelby County. AYES: Schaben, Kenkel, Parkhurst NAYES: None Brandon Burmeister, Shelby County Solid Waste Board Director asked for the Supervisors to re-appoint the following members to the Shelby County Solid Waste Board Stacey Ferry and Gene Gettys. Schaben made a motion to approve the reappointments, Parkhurst seconded the motion. The motion passed.

Burmeister then discussed the annual fuel bid and asked for Supervisor permission to notify past bidders and place an ad in the local paper for fuel bids for the upcoming year for the Secondary Roads department. Parkhurst made a motion to allow and Schaben seconded the motion, the motion passed.

Burmeister also recommended approval of the following resolutions 2024-7 and 2024-8. **RESOLUTION 2024-7 Bridge embargo**

WHEREAS: The Board of Supervisors is empowered under authority of Sections 321.236 Sub. (8), 321.255 and 321.471 to 321.479 to prohibit the operation of vehicles or impose limitations as to the weight thereof on designated highways or highway structures under their jurisdiction, and WHEREAS: the County Engineer has completed (or has caused to be completed) the Structure Inventory and Appraisal of certain county bridges, in accordance with the National Bridge Inspection Standards and has determined (or it has been determined) that they are inadequate for two-lane legal loads at allowable operating stress. NOW, THEREFORE, BE IT RESOLVED by the Shelby County Board of Supervisors that vehicle and load limits be established and that signs be erected advising of the permissible maximum weights thereof on the bridges listed, as follows:

RESOLUTION 2024-8 Road Embargos

WHEREAS: The Board of Supervisors of Shelby County, Iowa, consisting of the following members: Steve Kenkel, Chairman; Bryce Scvhaben Vice-Chairman; and Charles Parkhurst member; met to

consider placing load limits on selected "Load Sensitive" road surfaces in the Shelby County Secondary Road System, to prevent frost break up, excessive load break up, etc. WHEREAS: This authority is granted under Iowa Code Sections 321.236(8), 321.255, and 321.471 to 321.473 to prohibit the operations of vehicles upon Secondary Roads or impose restrictions as to weight of vehicles to be operated upon said secondary roads, except farm tractors as defined in Section 321.1, Subsection 7, for a total period not to exceed ninety days in any one calendar year, whenever any said highway by reason of deterioration, rain, snow or other climactic conditions will be seriously damaged or destroyed unless the use of vehicles thereon is prohibited or the permissible weights thereof reduced. WHEREAS: The Board states that all granular surfaced roads be embargoed and allowing only trucks and other vehicles with a gross weight of less than ten (10) tons to travel these roads. THEREFORE: The Shelby County Board of Supervisors resolves to hereby order the County Engineer to enact load limits of ten (10) tons, at his discretion, on all granular surfaced roadways within Shelby County. These limits shall become effective upon agreement to enact embargos by Chairman of Board of Supervisors and County Engineer and shall remain in effect until this resolution is redacted by the Shelby County Engineer. BE IT FURTHER RESOLVED that the Board of Supervisors, may, at their discretion, authorize permits of exemption for loads not already exempted by the previous paragraph of this resolution. Any such permit must be specific to the exempted vehicle and its load, and must bear an original signature, in red, of the board member authorizing the exemption. Neither the county engineer nor his staff is authorized to approve additional exemptions.

Parkhurst made a motion to approve resolution 2024-8, Schaben seconded the motion. Schaben, Kenkel and Parkhurst voted in favor of approval. No Nays were cast.

A utility permit was approved as recommended by the County Engineer after a motion by Schaben and a second by Parkhurst, the motion passed.

The reappointment of Janet Buman to the Conservation Board was then considered. Parkhurst made a motion to approve the nomination, Schaben seconded the motion the motion passed.

It was moved by Parkhurst, seconded by Schaben, that the County Auditor be authorized without prior approval of the Board to pay the wages of all County employees. Motion carried unanimously.

The Board had received the FY2025 Health Insurance rates from the Iowa State Association of Counties. Rates will remain steady for fiscal year 2025, it was noted that the traditional family plan is less than it was in fiscal year 2020 partially because Shelby County is a part of a multi-county insurance group. The employees covered by County Health insurance are diligent in keeping up with wellness plans offered, this lowers premiums and were lower than average the last two years. The total county cost for health insurance coverage options:

Plan 11-E Family - \$1,690.00 per month Plan 11-E Single-----\$ 753.00 per month Plan 12C Family (HSA)---\$1,863.00 per month Plus \$200 county contribution Plan 12C (HSA)---\$ 829.00 per month. Plus \$100 county contribution

Eligible for Family, opt out of health insurance benefit---\$490.00 per month, if application is completed. Eligible for Family coverage but take single coverage benefit---\$272.25 per month if application is completed.

Eligible for single coverage opt out of county health insurance benefit--\$217.75 per month if application is completed.

HSA single plans will receive \$600.00 in advance upon hire deposited into an HSA account, then \$100.00 monthly after 6 months of employment. HSA family plans will receive \$1200.00 in advance upon hire deposited into their HSA account then \$200.00 monthly after 6 months of employment.

Employee costs per month

Plan 11-E Family - \$248.25 per month Plan 11-E Single----\$ 71.25 per month Plan 12C Family (HSA)---\$186.30 per month Plan 12C Single (HSA)---\$ 24.87 per month.

Parkhurst motioned to approve the health insurance costs and benefits. Schaben seconded the motion.

Parkhurst, Schaben and Kenkel all voted to approve the health insurance rates and requirements for the fiscal year 2025.

The meeting was then recessed to allow time for organization of budget workshops. The meeting was resumed and no action was taken
