The Shelby County Board of Supervisors met in regular session at 9:00 A.M. in the Supervisors Chamber in the Courthouse with the following members present: Bryce Schaben, Charles Parkhurst, Mike Kolbe, and Taryn Knapp, Clerk.

Chairman, Bryce Schaben, asked that any conflict of interest be stated concerning any item on the agenda. None were stated.

It was moved by Kolbe, seconded by Parkhurst to approve the agenda. Motion carried unanimously.

It was moved by Parkhurst, seconded by Kolbe to approve the minutes of February 4th. Motion carried unanimously.

It was moved by Kolbe, seconded by Parkhurst to approve the latest processed claims to be paid. Motion carried unanimously.

Steve Kenkel, Pipeline Liaison for the BOS, gave an update on what he has been working on. Kenkel provided maps of where the proposed pipeline will pass through Shelby County. Kenkel stated there are 6 bills introduced to the House including topics of eminent domain and permit length. Mike Kolbe added that on March 4th Summit Carbon Solutions will have a representative attend the meeting to answer questions.

Chris Frederickson, Shelby County Engineer, asked the board for approval of Resolution 2025-10 for Establishing Permit Fees. It was moved by Parkhurst and second by Kolbe to approve Resolution 2025-10. Motion carried unanimously.

Frederickson presented a 28E Cooperative Agreement for a Competitive Highway Bridge Program (CHBP) Grant Project. This is a grant shared by other Counties and would be used towards a culvert replacement. Kolbe made a motion to approve the 28E agreement and Parkhurst seconded the motion. Motion carried unanimously.

Ruthanne Grimsley was present to represent Frank Powers, Chairman of the Compensation Board to give a recommendation for elected officials wages. The Compensation Board recommended a 3.5% increase for County Attorney, Auditor, Recorder, Treasurer, and Supervisor positions and 9.5% increase for the Sheriff. This recommendation included an approval for these positions to receive a stipend over and above the salaries approved by the Board of Supervisors. It was also recommended that the Auditor receive an additional stipend to prepare the budget with the amount left to be set by the Supervisors. Grimsley stated they also recommend the Chair of the Board of Supervisors receive an additional \$1,500 stipend over and above the regular salary. The Compensation Board recommended to follow the longevity schedule as stated in the handbook for all elected officials and recommended a revision of the longevity schedule to increase the amounts.

Elected Official salaries and longevity was then discussed. Parkhurst made a motion to approve a 6% increase for the Sheriff, 3.5% for all other elected officials, an additional stipend of \$1,500 for the Chair of the Board of Supervisors, and to follow the longevity schedule as stated in the handbook for all elected officials except for the County Attorney and Board of Supervisors who are part time.

A motion was then made by Kolbe and second by Parkhurst to approve the following publication of the wages of Shelby County employees for wages earned in calendar year 2024, as listed below:
