The Shelby County Board of Supervisors met in regular session at 9:00 A.M. in the Supervisors Chamber in the Courthouse with the following members present: Bryce Schaben, Charles Parkhurst, Mike Kolbe, and Taryn Knapp, Clerk.

Chairman, Bryce Schaben, asked that any conflict of interest be stated concerning any item on the agenda. None were stated.

It was moved by Parkhurst, seconded by Kolbe to approve the agenda. Motion carried unanimously.

It was moved by Kolbe, seconded by Parkhurst to approve the minutes of June 3rd, 2025, motion carried unanimously.

It was moved by Kolbe, seconded by Parkhurst to approve the latest processed claims to be paid. Motion carried unanimously.

Steve Kenkel, Pipeline Liaison's reported that Governor Reynolds did not sign the eminent domain bill, despite the Republican platform supporting the protection of eminent domain.

Engineer Chris Fredericksen presented a ROW permit for consideration from Harrison County REC. Kolbe made a motion to approve a permit to re-bury lines that are too close to the surface, Parkhurst seconded the motion. Motion carried unanimously.

Todd Valline's Chamber report on upcoming events and the Father's Day Flight breakfast this past weekend which had a great turnout. Valline also stated there will be 22 band members playing this year at the annual fireworks show in Harlan.

Supervisor Committee reports were brief with Mike Kolbe attending a couple meetings this past week.

The Shelby County Veterans Affairs Director Employment Agreement was then discussed. Kolbe made a motion to renew the agreement for a term of 3 years; Parkhurst seconded the motion. Motion carried unanimously.

Parkhurst made a motion to approve the 5-year Union Agreements with AFSCME 1014-4 Iowa Council concerning the Shelby County Emergency Management and Shelby County Sheriff's Office employees, as well as AFSME Iowa Council 61 Local 1014-2 Secondary Roads employee organization effective July 1, 2025, and authorize the Chairman to sign the final agreements, Kolbe seconded the motion. Motion carried unanimously.

SECTION 1. The Auditor is hereby authorized to transfer funds from the General Basic and from the Rural Basic Funds to the Capital Fund to cover expenditures as set out in the County Budget for Fiscal Year 2026.

SECTION 2. The Auditor is hereby authorized to transfer funds from the General Basic Fund to the General Supplemental Fund to cover expenditures as set out in the County Budget for Fiscal Year 2026.

SECTION 3. The Auditor is hereby authorized to transfer funds from the Rural Basic Fund and the General Basic fund to the Secondary Roads Fund to cover expenditures as set out in the County Budget for Fiscal Year 2026.

SECTION 4. The Auditor is hereby authorized to transfer funds from the Rural Basic Fund to the Flood & Erosion Control Fund and Capital Fund to cover expenditures as set out in the County Budget for Fiscal Year 2026.

SECTION 5. The Auditor is hereby authorized to transfer funds from the General Basic Fund to the Conservation Fund to cover expenditures as set out in the County Budget for Fiscal Year 2026.

WHEREAS, in accordance with Section 331.434(6) of the Code of Iowa which requires the Board of Supervisors of Shelby County, Iowa, to appropriate funds to operate all offices and departments of said county for Fiscal Year 2026.

THEREFORE BE IT RESOLVED, that the Board of Supervisors do hereby authorize the appropriations for Fiscal Year 2026 as follows:

SECTION 1: The amounts itemized by department on the following Schedule A are hereby appropriated from the resources of each fund so itemized.

SECTION 2: Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2025.

SECTION 3: In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amount appropriated pursuant to this resolution.

SECTION 4: If at any time during the budget year the Auditor shall ascertain that the available resources of a fund for that year will be less than said funds total appropriations she shall immediately so inform the Board and recommend appropriate corrective action.

SECTION 5: The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate on a report the status of such accounts to the applicable department monthly during the budget year.

SECTION 6: All appropriations authorized pursuant to this resolution lapse at the close of business June 30, 2026.
