

January 2, 2026

The Shelby County Board of Supervisors met in an organizational session at 9:00 A.M. in the Supervisors Chamber in the Courthouse with the following members present: Bryce Schaben, Charles Parkhurst, Mike Kolbe, and Taryn Knapp, Clerk.

The residing Chairman, Bryce Schaben, asked that any conflict of interest be stated concerning any item on the agenda. None was stated

It was moved by Parkhurst, seconded by Kolbe, to approve the agenda. Motion carried unanimously.

It was moved by Kolbe, seconded by Schaben, to approve Charles Parkhurst as Chairman of the Board of Supervisors for the 2026 calendar year and to approve Mike Kolbe as Vice-Chairman of the Board of Supervisors for the 2026 calendar year. Motion carried.

The Board of Supervisors shall meet as required by Chapter 331.213, Code of Iowa, and shall hold their first meeting of each year on the first day in January, which is not a Saturday, Sunday or holiday and shall hold all subsequent meetings of the year as scheduled by the Board. All meetings of the Board shall be scheduled and conducted in compliance with Chapter 21. Regular meetings shall be held on the first and third Tuesdays of each month.

It was moved by Kolbe, seconded by Schaben to approve the minutes of December 16th, 2025. Motion carried unanimously.

It was moved by Kolbe, seconded by Schaben to approve the claims of December 30th, 2025, as listed in the claims register. Motion carried unanimously.

The Meeting was then recessed and a hearing open for a budget amendment to the 2026 Shelby County Budget after a motion by Schaben and a second by Kolbe. Auditor Taryn Knapp gave the reasons for the amendment; EMS expenses were increased to include the purchase of an ambulance. General Assistance expenses were increased. EMS expenses were offset by revenues; General Assistance expenses increase will come from reserves.

Having had no comments from the public previously or at this meeting, Schaben made a motion to close the hearing, Kolbe seconded the motion. The motion passed.

It was moved by Schaben, seconded by Kolbe, that all claims filed in the Auditor's office by the Wednesday before the third Tuesday of each month shall be presented to the Board of Supervisors for approval for payment at that meeting. All claims for mileage and expenses must be submitted within sixty days of the date incurred. Department heads for hourly employees will be responsible for their employees submitting time sheets to the Auditor's Office by 8 AM Monday before payday. Motion carried unanimously.

The Supervisors then considered the 1% increase in wages for Calendar year 2026 for those

employees that qualified. Schaben made a motion to award the increase for the calendar year 2026. Kolbe seconded the motion, the motion passed.

Bonds for the required Elected officials were then considered; Iowa code requires these bonds to be in force. Kolbe made a motion to acquire and approve the bonds and ask a District Court Judge to approve the Supervisors bonds as also required. Schaben seconded the motion, the motion passed.

It was moved by Schaben, seconded by Kolbe, that the County Auditor be authorized without prior approval of the Board to pay the wages of all County employees. Motion carried unanimously.

It was moved by Kolbe, and seconded by Schaben, that the following resolution be adopted:

CONSTRUCTION EVALUATION RESOLUTION

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2026 and January 31, 2027 and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF SHELBY COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

BRIDGE EMBARGO

WHEREAS: The Board of Supervisors is empowered under authority of Sections 321.236 Sub. (8), 321.255 and 321.471 to 321.479 to prohibit the operation of vehicles or impose limitations as to the weight thereof on designated highways or highway structures under their jurisdiction, and

WHEREAS: the County Engineer has completed (or has caused to be completed) the Structure Inventory and Appraisal of certain county bridges, in accordance with the National Bridge Inspection Standards and has determined (or it has been determined) that they are inadequate for two-lane legal loads at allowable operating stress.

Kolbe made a motion to approve resolution 2026-7, Schaben seconded the motion, the motion passed. AYES: Schaben, Parkhurst, and Kolbe. NAYES: None.

RESOLUTION 2026-8

WHEREAS: The Board of Supervisors of Shelby County, Iowa, consisting of the following members: Charles Parkhurst, Chairman; Mike Kolbe, Vice-Chairman; and Bryce Schaben, member; met to consider placing load limits on selected "Load Sensitive" road surfaces in the Shelby County Secondary Road System, to prevent frost break up, excessive load break up, etc. **And WHEREAS:** This authority is granted under Iowa Code Sections 321.236(8), 321.255, and 321.471 to 321.473 to prohibit the operations of vehicles upon Secondary Roads or impose restrictions as to weight of vehicles to be operated upon said secondary roads, except farm tractors as defined in Section 321.1, Subsection 7, for a total period not to exceed ninety days in any one calendar year, whenever any said roadway by reason of deterioration, rain, snow or other climactic conditions will be seriously damaged or destroyed unless the use of vehicles thereon is prohibited or the permissible weights thereof reduced. **And WHEREAS:** The Board states that all granular surfaced roads be embargoed and allowing only trucks and other vehicles with a gross weight of less than ten (10) tons to travel these roads. **THEREFORE:** The Shelby County Board of Supervisors resolves to hereby order the County Engineer to enact load limits of ten (10) tons, at his discretion, on all granular surfaced roadways within Shelby County. These limits shall become effective upon agreement to enact embargos by Chairman of Board of Supervisors and County Engineer and shall remain in effect until this resolution is redacted by the Shelby County Engineer. **BE IT FURTHER RESOLVED** that the Board of Supervisors, may, at their discretion, authorize permits of exemption for loads not already exempted by the previous paragraph of this resolution. Any such permit must be specific to the exempted vehicle and its load, and must bear an original signature, in red, of the board member authorizing the exemption. Neither the county engineer nor his staff is authorized to approve additional exemptions.

Schaben made a motion to approve resolution 2026-8, Kolbe seconded the motion. Parkhurst, Kolbe, and Schaben voted in favor of approval. No Nays were cast.

It was moved by Schaben and seconded by Kolbe to appoint Jay Ring as Weed Commissioner for 2026. Motion carried unanimously.

It was moved by Kolbe and seconded by Schaben to approve the appointment of Taryn Knapp as General Assistance Director. Motion carried unanimously.

Schaben made a motion to appoint Paulette Madssen to the Conservation Board for a 4-year term, Kolbe seconded the motion. Motion carried unanimously.

Kolbe made a motion to set the mileage reimbursement rate at 72.5 cents per mile as well as the following days shall constitute paid holidays for all eligible employees as stated herein for the 2026 year:

Schaben seconded the motion to approve the Mileage rate and Holidays for Calendar year 2026. Motion carried unanimously.

The Board has received the FY2027 Health Insurance rates from the Iowa State Association of Counties. Shelby County is a part of a multi-county insurance group and employees covered by County Health insurance diligently keep up with the wellness plans offered, which helps lowers premiums.

The total premium for health insurance coverage options:

Plan 1 Family - \$1,770.00/month (Employee cost \$318.60)

Plan 1 Single - \$788.00/month (Employee cost \$94.56)

Plan 5 Family (HSA) - \$1,950.00/month plus \$200 county contribution (Employee cost \$234.00)

Plan 5 (HSA) - \$868.00/month. Plus \$100 county contribution (Employee cost \$43.40)

Eligible for Family, opt out of health insurance benefit---\$490.00 per month, if application is completed.

Eligible for Family coverage but take single coverage benefit---\$272.25 per month if application is completed.

Eligible for single coverage opt out of county health insurance benefit---\$217.75 per month if application is completed.

HSA single plans will receive \$600.00 in advance upon hire deposited into an HSA account, then \$100.00 monthly after 6 months of employment. HSA family plans will receive \$1200.00 in advance upon hire deposited into their HSA account then \$200.00 monthly after 6 months of employment.

The County's total cost for dental and vision insurance coverage options

Single Vision Premium \$6.44 - Employee cost \$0.00

Family Vision Premium \$18.32 - Employee cost \$11.88

Single Dental Premium \$44.00 - Employee cost \$5.80

Family Dental Premium \$104.00 - Employee cost \$64.22

Schaben motioned to approve the health, dental, and vision insurance costs and benefits, Kolbe seconded the motion. Schaben, Parkhurst, and Kolbe all voted to approve the health insurance rates and requirements for the fiscal year 2027.

It was moved by Kolbe, seconded by Schaben to approve participation in the ISAC Wellness Program and those employees doing the minimum recorded levels of 80% getting physicals and 60% completing the online assessments offered will receive \$100.00. If the qualified employees, as a group, reach 90% completion of the physical and 60% of the assessments they will receive \$150.00. If the qualified employees achieve a 100% completion of physicals and 60% online assessments the qualified employees will receive \$200.00. It was further added that the Wellness Coordinator will be paid \$500.00 if the County achieves the 5% insurance discount and 100% physicals completed and 60% assessment participation, only \$400.00 if the County achieves the 5% insurance discount and 90% getting physicals and 60% assessment participation, and only \$300.00 if the County achieves the 5% insurance discount and 80% getting physicals and 60% assessment completion. The motion passed unanimously.
